

# Summary of actions carried out with effect in Spain

<u>Custody of the Territory: Environment has allocated 2.1 million euros in projects since 2012</u> (2014). IUCN report "<u>Areas under Private Protection: Looking to the Future</u>" (2014). IUCN support for areas under private protection and land stewardship (2015).

<u>Land Stewardship Platform</u>, whose aim is to promote the development of stewardship as a tool for the conservation of natural, cultural and landscape resources in Spain as a whole. <u>The Map of the Custody</u> can be consulted on this website. Online platform to observe all the areas with Land Stewardship in Spain.

### Legislation:

Order AAA/78/2015, of 19 January, regulating the public prices of certain services of the National Centre for Environmental Education. The National Centre for Environmental Education (CENEAM) aims to increase citizen responsibility in relation to the environment, using environmental education as a tool. It provides educational activities through the Environmental Training Area and the assignment of use to public and private entities.

<u>Law 42/2007</u>, of 13 December, on Natural Heritage and Biodiversity. Includes promoting the use of fiscal measures to encourage private initiatives for nature conservation. The promotion will be carried out by the Public Administrations, which will encourage the custody of the territory through agreements between custody entities and owners of private or public properties whose main objective is the conservation of natural heritage and biodiversity.
