Requests the Director General to: work with IUCN Members and Commissions to raise international awareness to ensure co-responsibility of resource-rich countries in the conservation of migratory species; and provide technical and programmatic support for these efforts to strengthen initiatives and share conservation information. Requests the Director General and the Species Survival Commission to encourage the use of IUCN's expertise in monitoring the implementation of the Bern Convention and CMS. Urges all IUCN Members to cooperate in the conservation of migratory species and to share information that benefits their conservation. Calls on Member States to support the implementation of the CMS African-Eurasian Migratory Landbird Action Plan. Urges IUCN State members to provide financial and technical assistance to countries with less capacity to gain more knowledge about the abundance, distribution, biology and threats to migratory species and to take conservation action. It calls upon all countries to promote the coordination of policies and measures to ensure the conservation of migratory bird species.
